## **Notice Under ASX Listing Rule 3.10.5, Section 708A of the Corporations Act and Appendix 3B**

As detailed in its announcement 2 March 2018, Inca Minerals Limited (**Inca** or **Company**) entered into binding arrangements to raise \$160,000 via the placement of 26,666,667 fully paid ordinary shares, at an issue price of 0.6 cents per share (before raising costs) (**Placement**).

The Placement was made to Acuity Capital Investment Management Pty Ltd and funds will be used for exploration at the Company's zinc-silver-lead projects in Peru and for working capital.
